### **Essential Information for Users and Recipients of CITB Services**

#### General

The Construction Industry Training Board (CITB) was created at the request of the SA building and construction industry and is established by an Act of Parliament titled The Construction Industry Training Fund (CITF) Act 1993. CITB is a whole-of-industry led organisation that provides support to attract, train and retain South Australian building and construction workers by providing leadership in training and skills development.

## **Objectives**

CITB provides funding to the SA building and construction industry to improve the skills base of the workforce and to promote construction as a fulfilling career. This funding complements Government skills investment and recognises the unique and sometimes challenging circumstances around employment and training in the building and construction industry.

CITB accomplishes its objectives through support of structured programs and engagement with a range of stakeholders to ensure quality training is delivered to the industry. The programs and engagement are directed at three primary groups:

- 1. Secondary schools.
- 2. Apprentices and their employers.
- 3. The construction workforce, more generally.

### **Eligibility and Registration**

CITB's Eligibility Policy defines the eligibility of individuals and organisations who seek CITB funding support. The Policy can be found on the CITB website. It is the applicant's responsibility to provide evidence and confirm their eligibility for CITB funding prior to enrolling in a course or program or be in receipt of Apprenticeship Support Funding.

## **CITB Support Funding**

### **Short Course Training Support**

The Short Course program aims to raise the level of skill in the construction industry workforce by engaging eligible workers in structured training and skill development activities. CITB facilitates these training opportunities and ensures that the training it has funded meets both quality standards together with the outcomes required by industry.

An eligible person may access up to \$3,000 worth of training subsidies every 12 months with an approved CITB number. CITB's Funding Conditions for Endorsed Training Provider Short Course Training Support document outlines the aims, objectives and training provider eligibility requirements and is available on the CITB website.

## **Apprenticeship Training Support**

Apprentice Training Support (ATS) - CITB provides funding support to employers of eligible Apprentices/Trainees undertaking Training Contracts in industry-endorsed qualifications. The funding is to support on and off the job training provided to the apprentices.

Funding Type	Recipient	Purpose
Apprentice Training Support (ATS)	Employer	Contributes to the cost of on- and off- the- job training and assessment.
School Based Apprenticeship Training Support (SBATS)	Employer	To support secondary high school students to complete SACE whilst also undertaking an apprenticeship.
Mature Age Supplement (MAS)	Employer	To assist employers with the additional costs associated with employing adult apprentices.
Aboriginal Workforce Development Initiative (AWDI)	Employer	To improve the level of participation of Aboriginal and Torres Strait Islander apprentices/trainees in eligible vocations. AWDI includes subsidies for the employer to provide support for their apprentices. It also provides a mentoring service to assist apprentices and their employers to successfully complete.
Work Equipment Allowance	Apprentice	To assist new first year apprentices with cost of purchasing tools, work boots, Personal Protective Equipment or other work equipment items.
Career Driven	Apprentice	To assist new first year apprentices and doorways2construction students with free driving lessons.

## **Group Training Organisation (GTO)**

To improve the quality of on-job training, CITB provides funding to Endorsed GTOs for host employers to provide on-job training and development of skills and knowledge for each

# Levy

In accordance with the Construction Industry Training Fund (CITF) Act 1993, the operations of CITB are funded by a levy of 0.25% on SA building and construction work with a value greater than \$40,000.

### **Refunds**

CITB issues refunds of the CITF Levy in accordance with the Construction Industry Training Fund (CITF) Act 1993—Part 4, section 27, 28 and CITF Regulations 2021, section 8.

- 1. The Construction Industry Training Board is the only body authorised to issue refunds.
- 2. A refund may be applicable in the following circumstances:
  - a) If the final value of work is less than the original estimate by \$50,000 or more.
  - b) Work did not commence and will not commence in the future.
  - c) Duplicate payments for the same project.
  - d) Duplicate levy projects lodged for the same project.
  - e) Data entry error.

- · Rejected claims.


A complainant will be required to provide the following information:
